Co-sponsored by the OECD NEA, organized in cooperation with the International Atomic Energy Agency (IAEA), the China Nuclear Data Center is organizing the 14th International Conference on Nuclear Data for Science and Technology (ND2019), to be held in China National Convention Center in Beijing from 19 to 24 May 2019.

The main purpose of the third circular is to inform you of the postponement of the deadline for abstract submission and the IAEA support for potential participants from developing countries.

Abstracts Submission

The abstract submission system has been opened since this May. In response to a number of requests and in order to enable more time for potential participants, we are pleased to announce that the deadline for abstract submission has been postponed to November 20, 2018.

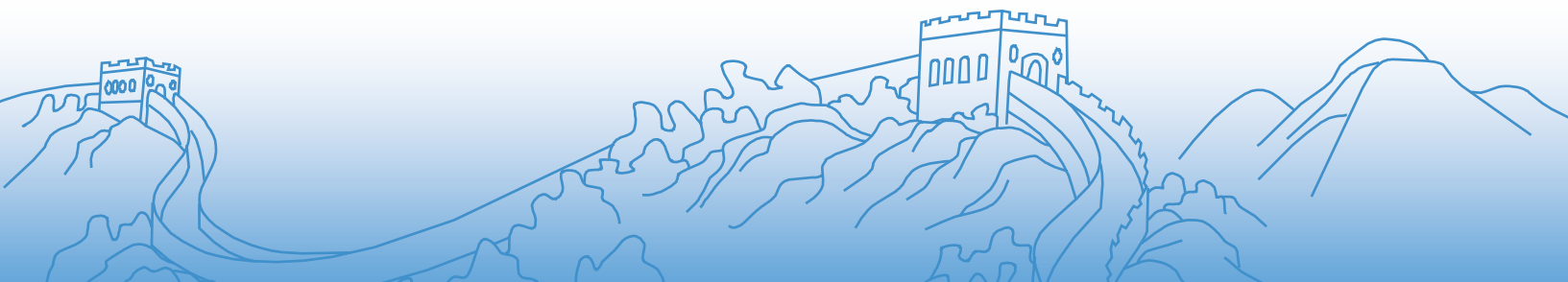
The abstracts are expected to be in plain text and special characters should be entered in the LaTeX format.

The process to review the abstracts will initiate as schedule, and the due date for us to notify the status of abstract acceptance is expected to remain on December 31, 2018.

ND2019 is planning to compile a program book including all abstracts submitted before due date. What's more, after a peer review process, a proceeding with full papers from registered participants are expected to be published in a nuclear-related academic journal, hopefully an SCI one. We will disclose the final solution in the next circular when we finish the negotiation with publishers.
